CAF AMERICA TAX=DEDUCTABLE OPTION

The Egmont Trust is able to accept tax-deductible donations from our US supporters in partnership with CAF America. Should you already hold a Charity Account with CAF, or wish to nominate Egmont to receive a grant via a Corporate CAF fund, you should be able to arrange payment through your usual channels.

Some additional information - CAF America passes your donation to CAF UK who deduct admin fees, currently 8% up to \$100,000, and credit our bank account. It can take up to 6 weeks before we receive notification and the funds. Corporate grant payments are usually received directly.
